**Check-in** will start at 7:15 a.m., with the first dog on the line at 8:00 a.m.

**Equipment familiarizations:** There will be supervised contact equipment familiarization for **Novice Dogs** only *each morning* before the Novice Std class begins.

**Food:** No food is available on the grounds, but available within 5 min. of the trial grounds.

### **Classes Offered**

Regular, Selected, Veteran: Standard and Jumpers with Weaves

Dogs running in Selected must begin at the Novice Level. The titles earned in the Regular class will not change because the dog has entered the Selected Class. Dogs may move between Regular and Selected Classes but not in the same set of trials. Titles earned in Regular classes and Selected Classes are recorded and separate titles.

Selected Classes are not divided into Novice A and B (All dogs run in one Novice Class)

Regular Classes: Novice “A” class is for persons and dogs that have never acquired an agility title with any country or with any organization. (8.1.2) Agility Novice “B” class is dogs handled by agility instructors and judges, and for dogs that have or have not acquired the Agility Novice title, but have not earned a qualifying score in Agility Intermediate and is for dogs handled by persons who have previously exhibited a dog to an agility title in any agility organization.

Regular and Selected Standard and JWW Intermediate class is open to dogs that have acquired the Agility Novice title, and to those dogs which have acquired the Agility Intermediate title, but have not yet acquired a qualifying score towards the Agility Excellent title.

Regular and Selected Std. and JWW Excellent “A” class is for dogs that have acquired the Agility Intermediate title, but have not yet earned the Agility Excellent title.

Regular and Selected Std. and JWW Excellent “B” class is for dogs that have acquired the Agility Excellent, the Agility Master Excellent, Agility Excellent Jumper or Agility Master Excellent Jumper titles.

**Veterans Class** Any dog 7 years or older may be entered in the Veterans Class. Once entered in the Veteran Class a dog may not revert to the Regular or Selected classes. The dogs will retain titles or qualifying scores and titles will be transferred to the veteran class. Veteran dogs may jump one or two heights lower than their Regular jump height.

**FEO (For Exhibition Only) may enter any class and any height.**

### **Height Divisions**

Handlers are responsible for entering the correct height division. The judge may request any dog be measured.

**Selected Class and Veteran Class** dogs will jump one height lower than the equivalent regular class height shown in the table below and dogs who measure 10” or below will jump 4” in the Selected Class.

The following jump height divisions shall be used in all regular classes:

8 inches for dogs 10 inches and under at the withers	
12 inches at the withers	for dogs 14 inches and under
16 inches at the withers	for dogs 18 inches and under
20 inches at the withers	for dogs 22 inches and under
24 inches at the withers	for dogs over 22 inches at the withers

**Obstacles** Agility obstacles shall meet the requirements of the CKC Agility Rules and Regulations effective January 2010. **Electronic timing** will be used.

All particulars called for on the entry form must be complete. Any telephone calls required to confirm information will be made COLLECT. Exhibitors must abide by errors made in entering their dog/s regardless of how or by whom the entries were made. No entry will be accepted unless accompanied by full entry fees. The B&DKC can not accept fax or phone entries and reserves the right to refuse any entry, subject to CKC rules. If because of riots, civil disturbances or acts beyond the control of the Trial Committee, it is impossible to open or complete the trial, no refund of entry fees will be made. All entry confirmation and judging schedules will be mailed or e-mailed as soon as possible after entries close.

**Attention U.S. Exhibitors:** We will accept U.S. checks as noted in entry fees. Due to the constantly fluctuating currency rates, discounted checks will not be accepted. Personal checks will be accepted; however, they must be made payable in U.S. funds in amounts noted under entry fees.

**Listing Fees** A CKC listing fee of \$9.40 Can. or US per dog per trial is payable with the entry fee if the entry of the dog does not include a CKC individual Registration number, PEN (Performance Event Number), ERN (Event Registration Number), or Miscellaneous Certificate Number (MCN).

**Eligibility:** To be eligible to compete in this trial, a dog must be at least 18 months of age and registered with the CKC or eligible for registration with the CKC, have a PEN, an ERN or have a CKC MCN (Miscellaneous Certificate Number). Bitches in season are not permitted to compete in the trial however, entry and listing fees will be returned, providing a veterinarian's certificate stating that the bitch was in season within the 10 day period preceding the trial is submitted to the Trial Secretary on or before the day of the trial.

**Note:** The CKC has given the Belleville Club permission to accept FEO (for exhibition only) entries this year for any dog not entered in the official trial. Dogs do not need a registered number and may be mixed breeds. These dogs will run in the height and class entered and will be judged by CKC rules.

“It shall be the duty and obligation of the trial giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred”. (4.1.3 t)

**Awards and Prizes:** (for qualifying scores, only)

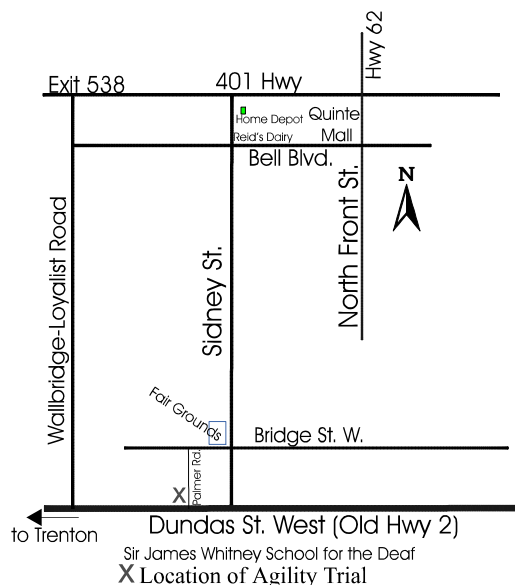
**Ribbons:** will be awarded for 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> places as well as for all qualifying scores.

**Rosettes** will also be offered for any new title earned at this trial.

**Directions to the trial site:**

*From the west:* exit Hwy 401 at Wallbridge-Loyalist Rd. (exit 538) turn right on Wallbridge-Loyalist Rd. and follow to lights at Old Hwy 2 (Dundas St. West) Turn left and continue 2.3 km. Watch for signs. Turn left into the main gate of Sir James Whitney School and turn left again. Follow the signs for Parking.

*From the east:* Exit Hwy 401 at Hwy 62 South (North Front St.) Turn right at first lights (Bell Blvd.) At fourth set of lights (Sidney Street) turn left. Follow Sidney St. to Dundas St. and turn right onto Dundas St. West. After lights on Palmer Rd. turn right into Sir James Whitney School gates. Follow the signs for Parking.

***Precincts of the trial:*** All grounds within 200' of the ring area or the fenced area of the school grounds, whichever is less, shall be considered the trial grounds.

***Course Familiarization:*** Handlers in all classes are permitted to walk the course, without a dog, prior to the start of each class.

***Warm-up*** one jump will be provided in proximity to the ring area.

***Move-up option:*** Dogs may be moved up to the next class between days i.e., from Saturday to Sunday, by filling in the required move-up form and dogs may move from Excellent A to B between trials, however, no other move-ups will be permitted between trials on the same day.

Under the CKC's 'show modeling' program, we have permission to offer FEO runs for any dogs not entered in the regular trial. No CKC number is needed to take part in FEO runs. Runs will be judged by our CKC judges following CKC rules. CKC will not be tracking these scores. Qualifying scores from these runs will receive an unofficial qualifying score ribbon from the Belleville Club, but it will not be counted towards official CKC titles. Exhibitors may enter FEO runs as many times as they like at a trial. An FEO run will be accepted **ONLY** if there is room in that class. FEO dogs run after the Veterans in their jump height.
