TRACKING FEE - NON CKC MEMBER CANADIAN RESIDENTS ONLY

Effective January 1, 2011 the CKC will be instituting a tracking fee for all Canadian residents who participate in a CKC event but are not CKC members. In order to protect any points and awards earned at any CKC event, a resident non-member can choose to become a CKC member or pay the tracking fee of \$55.00 for each dog. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. This applies to dogs wholly owned by non members resident in Canada and does not apply to U.S. exhibitors nor to CKC members or dogs co-owned with a CKC member

U.S. POSTAL ADDRESS

All entries must be received at the Marine City Post Office Box by 1:00 p.m. on the day of closing. Any entries received at the US Post office Box after that time & date will be considered received after closing, and not eligible for entry into the show.

ATTENTION FOREIGN EXHIBITORS

Please note that fees are due and payable in Canadian Dollars. Due to the constantly fluctuating currency rates, discounted cheques will not be accepted.

Personal cheques will be accepted, however, they are to be payable in Canadian Funds. If you send a cheque in US

Funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor.

Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks.

To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian Funds.

EVENT REGISTRATION NUMBER (ERN)

Effective Jan 1/92, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events, will no longer require a CKC registration number but will require an Event Registration Number (ERN). The ERN number MUST be applied for within 30 days of the first day of entering a CKC event. **Fee Is \$ 58.35 per dog.** For further information, The Canadian Kennel Club, Phone (416) 675-5511 FAX (416) 675-6506 9:00 a.m. – 5:00 p.m.

PERFORMANCE EVENT NUMBER (PEN)

Effective Jan 01, 2002, a Performance Event Number (PEN), allows an unregistrable dog of a CKC recognized breed to participate in those competitive events that are appropriate for the breed. Those events are as follows: Obedience, Tracking, Herding, Draft Dogs, Agility, Lure Coursing, Earthdog Tests, Hunt Tests, Working Certificate Tests, and Pointing Field Dog Tests. A Dog that is eligible for a PEN may not be entered as a listed dog. Dogs may only enter events after a PEN has been issued to that dog. This restriction shall also apply to dogs with ILP numbers. Unregistrable Dog means, a dog of a recognized CKC breed that cannot be registered because of unknown parentage or the unavailability of its registration papers.

MOVING UP – OBEDIENCE

CKC RULES AND REGULATIONS (EFFECTIVE JANUARY 01, 2008)

6.8.1 A dog that is registered in the records of the CKC or has a PEN, and ERN, or a MCN and has fulfilled the requirements for a title in accordance with these rules but at the time of the closing of entries for the trial has not received confirmation of the title may be moved to the next level of competition providing the request is submitted to the trial secretary on the appropriate move-up form by the owner or handler a minimum of one hour before the opening of the first trial on that day, schedule permitting.

6.8.2 When one or more trials are held on the same day in the same venue, the request for moving the dog up must be made a minimum of one hour prior to the scheduled start of the trial for which the dog is being moved up to, schedule permitting. The Trial Secretary shall amend the judge's book and the marked catalogue, which is to be sent to the CKC with the requests attached to the appropriate entry forms.

CLASSES – OBEDIENCE

The following Official CKC Classes will be provided:

Novice "A", Novice "B", Open "A", Open "B", & Utility & **Non-Regular** – Exhibition Only

Novice "A" and Open "A": One dog only may be entered in these classes by any one exhibitor, and every dog must be exhibited by the owner, or a member of the owner's immediate family. No licensed handler, no trainer, nor any person who previously exhibited a dog through it's U.D. title anywhere, shall be allowed to compete in the "A" Class.

A dog which has won a comparable degree in any foreign country is not eligible for entry in the "A" Class but may enter the "B" Class.

Novice "B" and Open "B": If an exhibitor enters more than one dog, each dog must have a separate handler for the sit and down exercise

Utility Class - The obedience Utility Class shall be for dogs of any recognized or listed breed and of either sex which shall have earned the title of C.D.X. (Companion Dog Excellent) in Canada. Dogs in this class may be handled or exhibited by the owner or any other person. However, the same person must handle the dog in all exercises.

General Entry Information

- ◆ **Please forward all inquires regarding entries to COLMAR SHOW SERVICE**
- ◆ Limited number of catalogues will be available at the show for \$ 4.00 CDN or USD.
- ◆ To comply with instructions issued by the Canadian Kennel Club we will be unable to accept, cancel, alter, or substitute an entry reaching our Show Secretary after the closing date.
- ◆ Alterations, substitutions or cancellations of any entry after the closing date is prohibited except for moving class dogs to Specials or moving to a higher class as provide d by the CKC Rules & regulations.
- ◆ All entry confirmations and **Judging Schedules** will be mailed as soon as possible after entries close.
- ◆ Tendering an **NSF cheque** in payment of fees shall be considered non-payment and is an offense punishable by disciplinary action and cancellation of awards.
- ◆ It is your responsibility to verify the receipt of any electronic entries prior to the advertised closing date. A valid means of payment must accompany all entries.
- ◆ Overpayments will be applied to the General Trophy fund, therefore, please calculate fees carefully.
- ◆ No entry will be accepted unless accompanied by full entry fees. NO post-dated Cheques.
- ◆ **Incomplete entries** will be returned.
- ◆ Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.
- ◆ Only dogs eligible for registration with CKC may enter this show and trial.
- ◆ **Bitches, when in season**, are not permitted to compete in the Trial, however, entry fees will be refunded, providing a veterinarian's certificate stating that the bitch was in season within the 10 day period preceding the trial, is submitted to the Trial Secretary, on or before the date of the trial.
- ◆ **The Belleville & District Kennel Club & COLMAR Show Service reserves the right to refuse any entries, subject to CKC rules.**
- ◆ The **Show precincts** will be the entire JG Demeza Sports Centre and 20' from any other show ring. No un-entered dogs will be allowed within the precincts of the trials.
- ◆ The B & DKC will not be responsible for any Items left overnight.
- ◆ The Show Superintendent/Obedience Chair will be in full charge of the show, governed by CKC rules. If, because of riot, civil disturbance or other acts beyond the controls of the management, it is impossible to open or complete the show or trial, no refund of Entry Fees will be made.
- ◆ The Belleville & District Kennel Club will use care and diligence for the welfare of all dogs, exhibitors and spectators but will not be responsible for, nor assume any liability in the event of accident or misfortunes, however caused.

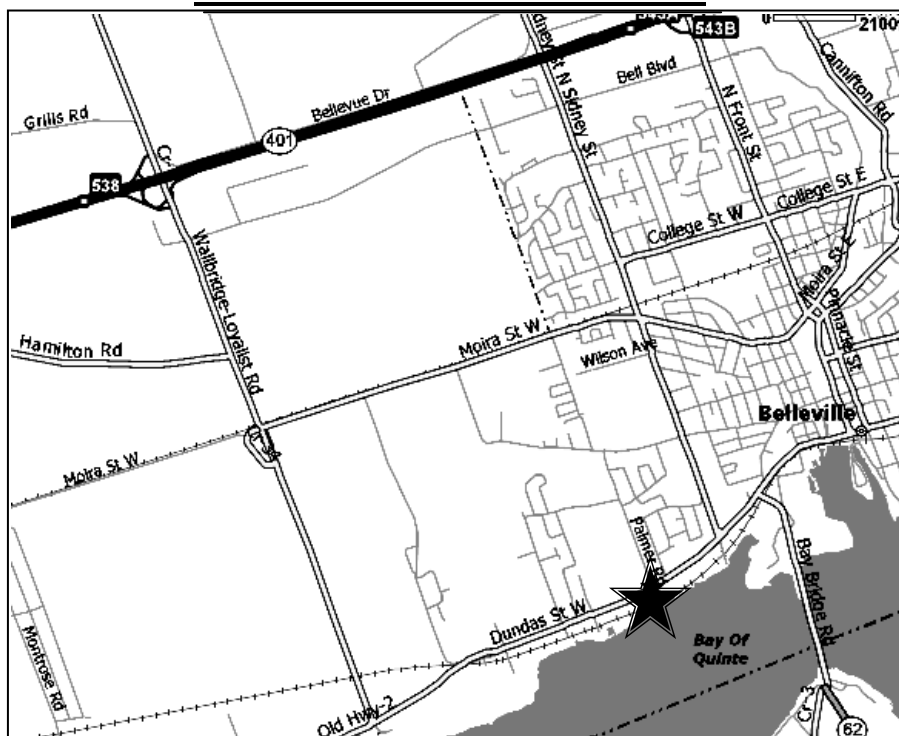
